
Today as a nation we move to the 'Living with Covid' guidelines. (Please see the back page for current advice that schools are receiving.) With national statistics showing that 1 in 13 people in England had Covid this week, we cannot be complacent especially with such vulnerable children in school, so we shall err on the side of caution where we have the flexibility to do so. The summary of DfE advice is: Stay off if feeling unwell and avoid contact with others, return only when temperature is back to normal and feeling well; Adults testing positive are to stay off and not contact others for 5 days, children testing positive are to stay off and not contact (non-essential) others for 3 days.

Our staff will also continue to test twice weekly whilst our LFT stocks last and as a residential special school we will be able to receive further tests if there is a Covid outbreak. For now we will continue to wear masks in corridors and communal areas of school and for close personal care. We continue to minimise mixing and children are still eating in their separate classrooms. We continue to encourage respiratory and hand hygiene. These additional precautions will remain in place and under review as Covid case numbers are monitored and will remain at least until all pupils have had the opportunity to be as well protected as the adults. DfE Guidance:

Changes to measures and guidance for managing COVID -19 in education and childcare settings from Friday 1 April

On Tuesday 29 March, the Secretary of State for Health and Social Care, Sajid Javid, set out the <u>next steps for living with COVID-19</u> in England from Friday 1 April. Free COVID-19 tests will continue to be available for specific groups, including eligible patients and NHS staff, once the universal testing offer ends on Friday 1 April.

Updated guidance will advise:

- adults with the symptoms of a respiratory infection, and who have a high temperature or feel unwell, should try to stay at home and avoid contact with other people until they feel well enough to resume normal activities and they no longer have a high temperature
- children and young people who are unwell and have a high temperature should stay at home and avoid contact with other people. They can go back to school, college or childcare when they no longer have a high temperature, and they are well enough to attend
- adults with a positive COVID-19 test result should try to stay at home and avoid contact with other people for 5 days, which is when they are most infectious. For children and young people aged 18 and under, the advice will be 3 days

For education and childcare settings from Friday 1 April:

- regular asymptomatic testing is no longer recommended in any education or childcare setting, including in SEND, alternative provision and children's social care settings.
 Therefore, settings will no longer be able to order test kits
- residential SEND settings may be advised by their local health protection team to reintroduce some time-limited asymptomatic testing. This would be an exceptional measure, for targeted groups of staff and pupils or students (secondary age or above) in the
 event of a possible COVID-19 outbreak. These settings are scheduled to receive an automatic delivery of contingency supply test kits during the week commencing Monday 28
 March.
- the UK Health Security Agency (UKHSA) will publish new guidance. Most of the specific COVID-19 guidance for education and childcare settings will be withdrawn from GOV.UK on Friday 1 April.

guidance for special schools and other specialist settings guidance for parents and carers
